



# LACURIS D, CURING LACQUER FOR MORTARS AND CONCRETES



## Descripción

Transparent liquid based in sintetic resins diluted in solvents in order to act as a curated protective lining on concretes and fresh mortar.

## Aplication

It's sprayed onto mortar or concrete surfaces, mainly in summer time or high temperatures to prevent premature water evaporation and allowing an appropriated setting. Very suitable for concrete highways and roads, airport runways, industrial pavements, precast elements, canals, etc.

## Surface preparation

Not applicable.

## Modes of application

- Homogenizing properly the product before applying.
- Applying directly on the fresh mortar or concrete by a spray pistol.
  - The application must be done once the superficial water dissipate from the concrete or mortar.
  - The surfaces which will be coating after must be sanded in order to disposal the remains of the product.
