Descripción

Grating paste, made of vinyl resins and graded fillers (TYPE F of 1mm and TYPE G of 2mm). It has a strong resistance to the passing of time. It is suitable for the protection of interior and exterior supports in homes, premises, etc.

Aplication

Render for façades, courtyards, staiRwells, both indoors and outdoors.

Surface preparation

The background of application must be clean, free of grease, oil or loose particles. Once the support is sound, IMPRIMAIS primer is applied.

Modes of application

Mix it manually or mechanically using a low speed mixer (400 - 500 rpm).

- Apply our primcer IMPRILAIS by roller or brush.
- Let the primer dry completely.
- Apply with stainless steel trowel and then, once extended the product, when it starts to dry, work with a

trowel by moving it in vertically, horizontally or in

circles until producing the desired travertine or circular patterns.

- The support of application must be clean, free of grease, oil or loose particles.
- Mortars must be allowed to cure for at least 28 days.
- Do not apply when rain, freezing temperatures and other bad weatehr conditions are expected.

Clean up

Clean using large amounts of water.
