Use IMPRIMAIS SUPER or IMPRIMAIS M.U. primer (according to the type of support).

Apply with a paint brush, roller or sprayer gun.

Apply the first coating using DEPIS LISA ANTIMOHO by

diluting 10 to 20% in water(according to primer).

Once the first coating is dry, apply the second one undiluted.

A satin finish is achieved with ACRILAIS TRANSLÚCIDA ANTIVERDIN, diluted to 30%..

-Resistant to alkaly, wear and interior moisture.

- Soluble in water, colour-changeable and look smooth- matt.
